OCEANS: Protecting endangered sea turtles, sharks and marine mammals by educating the public on the damage caused to sea turtles from the use of shrimp nets, driftnets and baited hooks. The Organization monitors sea turtle nesting beaches in Texas and supports beach protection in Central America. The Organization conducts research in Costa Rica by tagging sea turtles and sharks to learn their migratory habits and to provide a protected swimway. In addition the Organization advocates the banning of selling shark fins.

SPAWN: Salmon Protection and Watershed Network - protecting Coho Salmon by educating the public on their native habitat, protecting the waterways and surrounding land allowing for continued spawning.
